The Concession Stand provides critical financial support to the BCA and its Youth Baseball/Softball teams. All proceeds directly benefit our players and their teams. In accordance with the "Parent Code of Conduct" signed with their registration form, The BCA Concession Stand Policy is as follows:

- At minimum, each family must work one game per child in the league at our concession stand during the season.
- Concession Stand volunteers must be at least 14 years of age.
- These positions are all volunteer in nature
- All members, fans and players are expected to act in a respectful manner while at the Concession Stand.
- Volunteers should arrive 15 minutes before game time to assist with stand preparations.
- For game cancellations or rain-outs in which you were scheduled to work the stand, it is expected that you will make up that shift for another game season.
- If for some reason you would be unable to work the game you volunteered for, you must find a replacement (14 years or older, including player siblings) and let the concession stand manager know as soon as possible. You will be expected reschedule your volunteer shift for another game.
- Families may "opt-out" of volunteering for the stand by indicating so on the next page of this policy and submitting the \$25.00 opt-out fee.
